All applications to the First Year Group or the Special Class (for ALL year groups) in Mullingar Community College will only be accepted after the 17/10/2022 and the closing date for receipt of applications is the 07/11/2022 at 4pm. Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy.

All transfer applications to the Second, Third, Fifth, Sixth, TY or LCA2 Groups in Mullingar Community College, other than to the Special Class, in 2023-2024 will only be accepted after the 09/01/2023 and the closing date for receipt of application is the 03/02/2023 at 4pm. Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy.

Please be reminded that, in line with the school's Admission Policy and the Education (Admission to Schools) Act 2018, all waiting lists going forward are only in place for the academic year to which they apply. Therefore, if a student is seeking a place in the Special Class and is not successful in a given academic year or is on a waiting list for this year, a new application must be made for the following year.
